Privacy Policy

Purpose

This Privacy Policy is designed to help you understand what kind of information we collect in connection with our products and services and how we will process and use this information. In the course of providing you with products and services we will collect and process information that is commonly known as personal data. This Privacy Policy describes how we collect, use, share, retain and safeguard personal data. This Privacy Policy sets out your individual rights, we explain these later in the Notice but in summary these rights include your right to know what data is held about you, how this data is processed and how you can place restrictions on the use of your data.

Who are we?

Six Global Markets LTD ("Six Global Markets") is a company registered in Mauritius and is duly licensed by the Mauritius Financial Services Commission as Investment Dealer (Full-Service – Excluding Underwriting).

How does Six Global Markets process your personal data?

This policy explains how Six Global Markets handles personal information and complies with the requirements of the Mauritius Data Protection Act 2017 (the "Act"). If you have any further questions in relation to this policy, please contact us at info@sixfx.com.

What is Personal Data?

Personal data is information relating to an identified or identifiable natural person. Examples include an individual's name, age, address, date of birth, gender and contact details. Personal data may contain information which is known as special categories of personal data. This may be information relating to an individual's health, racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, genetic and biometric data, or data relating to sexual orientation. Personal data may also contain data relating to criminal convictions and offences.

Collecting information relating to individuals

We will use your personal data for the performance of our contract with you, to provide you with our services as Investment Dealer (Full-Service – Excluding Underwriting), to administer your investments and our business, to respond to any requests from you about services we provide and to process complaints. We will also use your personal data to manage your account, perform statistical analysis on the data we collect, for financial planning and business forecasting purposes and to develop new and market existing products and services.

How we deal with and use the personal information

Our main purposes for collecting personal information about individuals are:

- Providing our services;
- Responding to requests;
- Maintaining client relationship;
- Notifying clients of our product offerings and developments;
- Reporting and management;
- Compliance purposes (we share information with third parties such as world-check, KYC 360);
- Any purpose that would relate to our business.

We may use personal information about individuals to market our services, including by email. However, individuals have the right to object to the processing of personal data concerning him/her for such marketing by emailing us at info@sixfx.com.

Disclosure of personal information

Six Global Markets does not routinely disclose personal information to other organisations unless:

- Required by law;
- Use or disclosure is permitted by this policy;
- We believe it necessary to provide you with a product or service which you have requested or are contracted to;
- To protect the rights, property or personal safety of any member of the public or a customer of Six Global Markets or the interests of Six Global Markets; or
- You give your consent.

Except as set out in this policy, we do not sell or trade personal information to third parties or allow such third parties to use that personal information.

Transfer of information outside Mauritius

We may transfer your data to third parties based outside of Mauritius. This is necessary for the purposes of administering our business and/or managing your investments. Such parties are not permitted to use your personal data for any other purpose than for what has been agreed with us. These parties are also required to safeguard your personal data through the use of appropriate technical and organisational data security measures and are prohibited from disclosing or sharing your data with other third parties without our prior authorisation, or unless as required by law. Your rights

• The right to be informed about the personal data being processed;

- The right of access to your personal data;
- The right to object to the processing of your personal data;
- The right to restrict the processing of your personal data;
- The right to rectification of your personal data;
- The right to erasure of your personal data.

Privacy on our website

This policy also applies to any personal information we collect via our website. In addition to personal information you provide to us directly, Six Global Markets may also collect personal information from you via its website. Cookies may be used on some areas of our websites. A cookie is a small software application which allows a website to recognise a previous user and to observe how a user navigates within a website.

Access to information

We will provide access to personal information upon request by an individual, except in the limited circumstances in which it is permitted for us to withhold this information. When you make a request to access personal information, we will require you to provide some form of identification (such as a driver's licence or passport) so we can verify that you are the person to whom the information relates.

Rectifications, erasure or restriction of processing

If you believe that information we hold about you is incorrect or out of date, or if you have concerns about how we are handling your personal information, please contact us and we will try to resolve those concerns. If you wish to have your personal information deleted, please let us know and we will take reasonable steps to delete it (unless we need to keep it for legal, auditing or internal risk management reasons). If Six Global Markets becomes aware of any ongoing concerns or problems concerning our privacy practices, we will take these issues seriously and work to address these concerns.
